On what Nature taught Descartes

This dissertation aims to square the methods and content of Descartes's final treatise, the *Passions of the Soul*, with his philosophical system. In doing so, I critique deductive-rationalist readings of his epistemic project, give a reading of Descartes's approach to the problem of mind-body interaction, comment on the role of resoluteness in his ethics, and make room for the second person perspective in his philosophy. My interventions are organized by a close reading of Descartes's correspondence with Elizabeth of Bohemia, which provides a clear narrative that relates these issues to one another.
